ORDER

CWP No.5518/2022 titled as Hem Raj,TGT(Med)VS State of H.P. & others.

The Petitioner Sh.Hem Raj,TGT(Med) filed CWP No. 5518/2022 titled as Hem Raj,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding his transfer from GSSS Charda (B.Kalhel) Distt. Chamba (which falls under hard /Tribal area) to his choice of station after the completion of required tenure as per policy. Pending application(s), if any , shall also stand disposed of".

As per direction of the Hon'ble High Court the petitioner submitted his representation to the undersigned ,in which he has requested that he may be adjusted at GHS Krori (Newly upgraded school),GHS Bihali u/c GSSS Saikothi/GSSS Loh Tikri/GSSS Chilli and GSSS Jalot Distt.Chamba against vacancy

From the perusal of the record, it reveals that Sh. Hem Raj ,TGT(Med), has been working in GSSS Charda(Kalhel),Distt. Chamba (which fall under hard/Tribal area),since 05-07-2018 and has completed his normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Charda(Kalhel) Distt. Chamba to GHS Krori u/c GSSS Pukhri(Kiani) against vacancy. With these observations the representation of the petitioner is considered and disposed of accordingly.
