**ORDER**

**In the matter :** CWP No.5518/2022 titled as Hem Raj,TGT(Med)VS State of H.P. & others.

The Petitioner Sh.Hem Raj,TGT(Med) filed CWP No. 5518/2022 titled as Hem Raj,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding his transfer from GSSS Charda (B.Kalhel) Distt. Chamba (which falls under hard/Tribal area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 16<sup>th</sup> August ,2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"Accordingly ,we dispose ofthis petition,by permitting the petitioner to file a fresh representation by setting up five stations out of which one station is essentially to be out of his home district. On such representation being made ,the respondents shall consider the same within two weeks and pass consequential orders of transfer of the petitioner within three weeks thereafter .Pending application( s),if any ,shall also stand disposed of".*

As per direction of the Hon'ble High Court the petitioner submitted his representation to the undersigned ,in which he has requested that he may be adjusted at GHS Krori (Newly upgraded school),GHS Bihali u/c GSSS Saikothi/GSSS Loh Tikri/GSSS Chillli and GSSS Jalot Distt.Chamba against vacancy

From the perusal of the record, it reveals that Sh. Hem Raj ,TGT(Med), has been working in GSSS Charda(Kalhel),Distt. Chamba (which fall under hard/Tribal area),since 05-07-2018 and has completed his normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Charda(Kalhel) Distt. Chamba to GHS Krori u/c GSSS Pukhri(Kiani) against vacancy. With these observations the representation of the petitioner is considered and disposed of accordingly.
