**ORDER**

**In the matter :** **CWP No.5465/2022 titled as Binkal Thakur,TGT(Med) VS State of H.P. & others.**

The Petitioner Sh.Binkal Thakur ,TGT(Med) filed CWP No. 5465/2022 titled as Binkal Thakur,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding his transfer fromGSSS Gaonsari Distt. shimla (which falls under hard /Tribal area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 31<sup>st</sup> August ,2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"Accoordingly ,we dispose of this petition,by directing the respondents to consider and decide the representation of the petitioner within three weeks and pass consequential orders of transfer of the petitioner to any one of the aforesaidfive stations. Pending application(s),if any,shall also stand dispose of"*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 14<sup>th</sup> Sep.2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted at GHS Daloh u/c GSSS Tihri(KGR) / GSSS Jhagriani(HMR)/GHS Upper Sehri(KGR)/GSSS Mahadev(KGR) against vacancy .

From the perusal of the record, it reveals that Sh. Binkal Thakur,TGT(Med),has been working in GSSS Gaonsari Distt. Shimla (which falls under hard/Tribal area),since 06-05-2019 and has completed his normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Gaonsari (SML) to GSSS Jhagriani Distt. Hamirpur against vacancy. With these observations the representation of the petitioner is considered and disposed of accordingly.
