ORDER

CWP No.5378/2022 titled as Sh. Kulvinder Singh ,TGT(Med)  
Vs State of H.P. & others.

The Petitioner Sh.Kulvinder Singh,TGT(Med) filed CWP No. 5378/2022 titled as Kulvinder Singh,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding her transfer from GHS Sinyur (Bharmour)Distt. Chamba (which fall under hard /Tribal area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 05<sup>th</sup> August,2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

*“ Accordingly , in the instant petition is disposed of by directing the respondents to consider and decide the case of the petitioner and then pass necessary consequential orders of transfer by posting him at any of the station mentioned hereinabove within a period of four weeks from today.”*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 14<sup>th</sup> Sep.2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted at GHS Baduhi Khas /GHS Thora u/c GSSS Jassaur/GSSS Khani/GHS Bagani Distt. Kangra (Newly up graded school)

From the perusal of the record, it reveals that sh. Kulvinder Singh,TGT(Med) has been working in GHS Sinyur (Bharmour) Distt. Chamba (which falls under hard/Tribal area),since 15<sup>th</sup> March,2019 and has completed his normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and he is hereby transferred from GHS Sinyur (Bharmour) Distt. Chamba to GHS Baduhi Khas u/c GSSS Baduhi (KGR) against vacancy.These orders will be effective when school is made functional. With these observations, the representation of the petitioner is considered and disposed of accordingly .
