ORDER

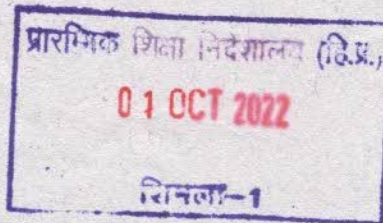
In the matter : **CWP No.5868/2022 titled as Sunil Kumar,TGT(Med) VS State of H.P. & others.**

The Petitioner Sh.Sunil Kumar,TGT(Med) filed CWP No. 5868/2022 titled as Sunil Kumar,TGT (Med),versus State of H.P.before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kushwa 15/20 Tehsil Nirmand Distt. (KLU) (which falls under hard /Tribal area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 29th August ,2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Accordingly ,we dispose of this petition, by directing the respondents to consider and decide the representation of the petitioner within four weeks and pass a , consequential orders of transfer of the petitioner to any one of the aforesaid seven station .Pending application(s),if any,shall also stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 14th Sep.2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted at GHS Haritayanger u/c GSSS Dangar (BLP)/GSSS Kallar/GHS Ludder Mahadev/GSSS Jhagriani/GHS Nagrota Gozian u/c GSSS Badahu /GHS Khatarwaru/c GSSS Ludder Mahadevand GSSS Bhagani Distt. Hamirpur against vacancy.

From the perusal of the record, it reveals that Sh. Sunil Kumar,TGT(Med), has been working in GSSS Kushwa, Distt. Kullu (which fall under hard/Tribal area),since 04-05-2019 and has completed his normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Kushwa 15/20 (Nirmand),Distt. Kullu to GHS Nagrota Gazian Distt. Hamirpur against vacancy. These orders will be effective when school is made functional.With these observations the representation of the petitioner is considered and disposed of accordingly.

Vs State of H.P. & others.

The Petitioner Smt. Rohini Dhiman, TGT(Med) filed CWP No. 5998/2022 titled as Smt. Rohini Dhiman, TGT (Med), versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Baggi Distt. Chamba (which falls under hard/Tribal area) to her choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 30th August, 2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

" In the circumstances, we dispose of the writ petition by permitting the petitioner to make a fresh representation to respondent No.2 within one week. If such representation is made, the same shall be decided by respondent No.2 expeditiously and in any event within three weeks from the date of receipt of the representation "

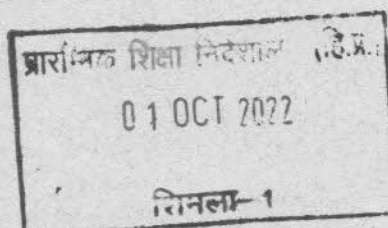
