ORDER

In the matter of: CWP No. 4389/2022 titled as Parveen Kumar Vs. State of H.P. & Others.

Whereas, Sn. Parveen Kumar, TGT (NM) preferred CWP No. 4389/2022 titled as Parveen Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Chardra Tehsil Churah District Chamba (sub-cadre area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 18.07.2022 when the Hon'ble High Court has passed the following orders:-

" 3. In the given circumstances, we deem it appropriate to dispose of this petition by directing the petitioner to file a fresh representation, clearly setting out therein five stations of his choice, out of which one essentially should be outside his home district. Needless to say that those stations shall be other than the one already considered by the respondents. Let needful be done within two weeks and thereafter a decision in this regard be taken by the competent authority within a further period of two weeks. Ordered accordingly. Pending application (s), if any, also stands disposed of."

Whereas, petitioner was submitted his representation to this office on 1.8.2022 vide which he has given five stations of his choice but there was no vacancy/longer stayee in these schools. However, the petitioner has asked to submit fresh representation to this office vide this office letter of even number dated 3.9.2022. The petitioner has submitted fresh representation to this office on 8.9.2022 vide which he has given ten stations of his choice.

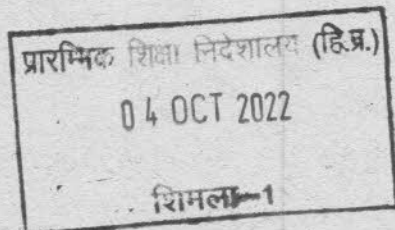
From perusal of record, it has been found that the petitioner has been working at GSSS Chardra Distt. Chamba (hard/sub-cadre area) since 16.8.2018 and has completed more than four years stay there. At present one post of TGT(NM) likely to be vacant in GMS Toru u/c GSSS Pihari Distt. Kangra due to promotion of present incumbent. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Chardra Distt Chamba to GMS Toru u/c GSSS Pihari District Kangra against vacancy being caused due to promotion of present incumbent, without TTA/Jt. These orders will be implemented after the relieving of present incumbent on promotion. The representation of the petitioner is disposed of accordingly.

ORDER

In the matter of: CWP No. 1786/2022 titled as Kulwant Singh Vs. State of H.P. & Others.

Whereas, Sh. Kulwant Singh, TGT (NM) preferred CWP No. 17869/2022 titled as Kulwant Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kushwa District Kullu to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 6.04.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without advertng to the merits of the case, this writ petition is disposed of with a direction that in case the petiotner moves a fresh representation to the respondents in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks from the receipt of the representation, in accordance with law. Pending application(s), if any, also stand disposed of."

Whereas, petitioner was submitted his representation to this office on 26.4.2022 vide which he has given three stations of his choice but there was no vacancy/longer stayee in these schools. However, the petitioner has submitted a fresh representation to this office on 20.9.2022 vide which he has requested to adjust him at GMS Sera u/c GSSS Darlaghat/GSSS Dhundan Distt. Solan against vacancy.

From perusal of record, it has been found that the petitioner has been working at GSSS Kushwa Distt. Kullu since 7.11.2016 and has completed more than five years stay there. At present one post of TGT(NM) is lying vacant in GSSS Dhundan Distt. Solan. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Kushwa Distt Kullu to GSSS Dhundan District Solan against vacancy. The representation of the petitioner is disposed of accordingly.
