Note: While implementing above transfers of teachers the norms and standards for providing teachers in a school as contained under Sr. No. 1(a) in the schedule of RTE Act 2009 be complied strictly. In case, any violation of these instructions you will be entirely responsible.

1. **These orders be implemented in relaxation of ban on transfer.**
2. **In case of Condonation of short stay willingness of the concern incumbent may be obtained first.**
3. Willingness of the concerned teacher be obtained by the in charge/Head of the institution before relieving him/her. In case he/she is not willing for the transfer, then he/she may not be relieved and the case may be referred back along with his/her unwillingness in r/o mutual transfers.
4. If the incumbent has already served sub-cadre/hard/tribal/difficult area in that event he/she not relieved again to areas
5. It must be ensured that the candidate is not specially abled.
6. It must be ensured that the candidate is not on the verge of retirement.
7. The transfer order of TGT's issued from the hard area to soft may not be implementing without joining of substitute.
8. Incumbent(s) have not completed of three years tenure in his/her present place of posting transfer orders may not be implemented, if otherwise stay of the incumbent(s) not condoned.
9. Transfer order issued in r/o TGT's working on contract basis may not be implemented, if contractual policy is not relaxed.
10. All provisions as contained in O/M No: PER (AP-3)E(3)17/2021 dated 10.07.2013 "Comprehensive guiding principles 2013 --for regulating the transfer of State Govt. Employee at point no.5" session to certain categories of employees and 5.5 of O/M dated 17.09.2015 must be adhered strictly.

1. The Dy. Director of Elementary Education, as mentioned above.
2. The Principal/Headmaster, as mentioned above. With the directions that the incumbent working under your establishment be relieved immediately failing which disciplinary action will be initiated against the defaulter under the rules. It must also be ensured that there is no court case before the relieving/joining of the concerned officials. The joining of the new incumbent be accepted only after the previous incumbent has been relieved. He/She will also ensure that the joining and relieving report is sent by him/her to Dy. Director of Elementary Education and to this Directorate immediately. If the controlling officer does not comply with this procedure the salary of the surplus incumbent will be drawn from the salary of controlling officer. Transfer of teachers on contract basis/teacher may not be implemented vice regular teacher.
