ORDER

In the matter of: CWP No: 6351/2022-Mahender Singh, TGT(Arts) Vs. State of Himachal Pradesh
(Regarding Transfer).

Sh. Mahender Singh, TGT (Arts) has filed CWP No. 6351/2022-before the Hon'ble High Court of H.P. regarding transfer from GMS Kyarik u/c GSSS Koti Dhiman, Distt.Sirmour. The case was listed on 22.09.2022, when the same has been disposed of with the following orders :-

The respondents to consider, decide the case of the petitioner and thereafter issue consequential orders of transfer of the petitioner to anyone of the five stations enumerated above. Ordered accordingly. Needful be done within four weeks from today.

The petition stands disposed of in aforesaid terms, so also the pending application (s), if any.

For compliance, to come up on 11.10.2022.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner was perused wherein the petitioner i.e Sh. Mahender Singh, TGT (Arts) stated that he is working in GMS Kyarik u/c GSSS Koti Dhiman (Sub Cadre) Distt. Sirmour and has completed normal tenure at his present place of posting. He has further stated that his wife is working at Jawahar Navodaya Vidyalaya Nahan and she has seven month old child. He has requested that due to adverse family circumstances he may kindly be transferred from GMS Kyarik u/c GSSS Koti Dhiman (Sub Cadre) to GHS Kodewala u/c GSSS Haripur / GHS Devka uc GSSS Surla/ GMS Puruwala u/c GSSS Puruwala, Distt.Sirmour, against vacancy.

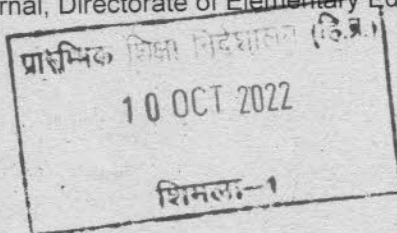
From the perusal of record, it is found that Sh. Mahender Singh, TGT(Arts) is working in GMS Kyarik u/c GSSS Koti Dhiman (SMR) since 04.03.2017 and has completed normal tenure at his present place of posting. He was transferred from GMS Kyarik u/c GSSS Koti Dhiman (Sirmour) to GSSS Jaiher (Sirmour) vide this Office Order dated 05.09.2022. At present post of TGT (Arts) is lying vacant in GHS Kodewala u/c GSSS Haripur Kol, Distt. Sirmour. Keeping in view the position stated above, representation of petitioner i.e Sh. Mahender Singh, TGT (Arts) who is under orders of transfer from GMS Kyarik u/c GSSS Koti Dhiman (Sirmour) to GSSS Jaiher (Sirmour) is considered sympathetically and he is hereby transferred from GMS Kyarik u/c GSSS Koti Dhiman, Distt. Sirmour to GHS Kodewala u/c GSSS Haripur Khol, Distt. Sirmour. The representation of the petitioner is disposed of accordingly.
