**ORDER**

In the matter of: CWP No. 4522/2022 titled as Virender Kumar Vs. State of H.P. & Others.

Whereas, Sh. Virender Kumar, TGT (NM) preferred CWP No. 4522/2022 titled as Virender Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Brall u/c GSSS Sheel District Shimla to the station near to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 8.07.2022 when the Hon'ble High Court has passed the following orders:-

*" 2. In the circumstances, we dispose of the petition by directing respondent No. 2, the Director, Elementary Education, Himachal Pradesh, to decide the representation of the petitioner expeditiously and in any event within three weeks from today. The petition to stand disposed of in the aforesaid terms, so also pending miscellaneous application(s) if any."*

Whereas, petitioner had submitted his representation to this office on 19.7.2022 vide which he had given five stations of his choice but these schools/stations has been filled up. Hence, the petitioner has given a fresh representation to this office on 30.9.2022 vide which he has requested to adjust him at GSSS Kulhera(Hamirpur)/Nalyana(Mandi)/Soldha/GMS Sai Kharsi u/c GSSS Soldha(Bilaspur)/GMS Pipalaghat u/c GSSS Chhakoh Distt. Bilaspur against vacancy.

From perusal of record, it has been found that the petitioner has been working at GHS Brall u/c GSSS Sheel Distt. Shimla since 9.3.2019 and has completed more than three years stay there. At present one post of TGT(NM) is lying vacant in newly upgraded GMS Sai Kharshi u/c GSSS Soldha Distt. Bilaspur. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GHS Brall u/c GSSS Sheel Distt Shimla to newly upgraded GMS Sai Kharshi u/c GSSS Soldha District Bilaspur against vacancy. These orders will be implemented after GMS Sai Kharshi u/c GSSS Soldha Distt. Bilaspur is made functional and petitioner will be relieved then only from the present school of his posting. The representation of the petitioner is disposed of accordingly.
