ORDER

In the matter of: CWP No: 6687/2022-titled as Vijay Kumar,TGT(Arts) Vs. State of Himachal Pradesh (Regarding Transfer).

Sh. Vijay Kumar, TGT (Arts) has filed CWP No. 6687/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Shilla, Distt. Shimla. The case was listed on 22.09.2022, when the same has been disposed of with the following orders :-

The petitioner to make a fresh representation to respondent No.2 within a period of one week from today. If such representation is made, the same shall be decided by respondent No.2 not later than four weeks from the date of receipt of the representation. The pending application (s), if any also to stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Vijay Kumar, TGT (Arts) has submitted representation vide which he stated that he was initially appointed as TGT(Arts) on 29.09.2017 and posted at GSSS Shilla, Distt. Shimla. He has further stated that GSSS Shilla falls under category of Rural area and one and half Km on foot journey to reach the school. He has requested that due to adverse family circumstances he may kindly be transferred from GSSS Shilla, Distt.Shimla to GSSS Samlet/ GSSS Banoli/ GSSS Gharjarot/ GSSS Badhuhi/ GSSS Sidhur Ghar/ GSSS Khatiar, Distt.Kangra.

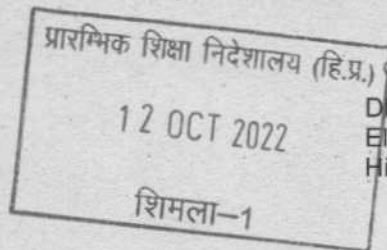
From the perusal of record, it is found that Sh. Vijay Kumar, TGT(Arts) is working in GSSS Shilla, Distt. Shimla since 09.10.2017 and has completed normal tenure at present place of posting. GSSS Shilla exists in soft area of Distt. Shimla and as policy the teachers who have served in sub cadre /hard area have the option to be posted at a station of choice. One post of TGT(Arts) is lying vacant in GHS Indpur, Distt.Kangra. Keeping in view the position stated above, representation of petitioner i.e Sh. Vijay Kumar, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Shilla, Distt. Shimla to GHS Indpur, Distt. Kangra, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

ORDER

In the matter of: CWP No. 6658/2022 titled as Anup Singh Rana Vs. State of H.P. & Others.

Whereas, Sh. Anup Singh Rana, TGT (NM) preferred CWP No. 6658/2022 titled as Anup Singh Rana Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Gad u/c GSSS Chowai Distt. Kullu to nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 21.09.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Without going into the merits of the case, we dispose of the present writ petition by permitting the petitioner to make a fresh representation to respondent No. 2-Director Elementary Education, Himachal Pradesh, if such representation is made within one week from today, the same shall be decided by the respondent No. 2, within six weeks from the date of receipt of representation. Pending miscellaneous application(s), if any, also to stand disposed of."

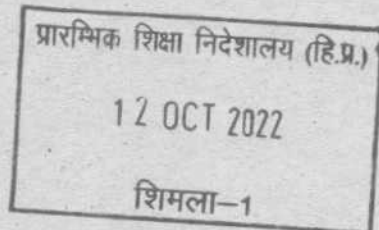
Whereas, petitioner was submitted his representation to this office on 22.9.2022 vide which he has given five stations of his choice i.e. GMS Rawa u/c GSSS Kareri Distt. Kangra/GMS Upper Punner u/c GSSSS Punner/GMS Lot u/c GSSS Utrala/GSSS Shahpur/Toru District Kangra against vacancy.

From perusal of record, it has been found that the petitioner has been working at GMS Gad u/c GSSS Chowai Distt. Kullu since 29.8.2018 and has completed more than four years stay there. At present one post of TGT(NM) is lying vacant in newly upgraded GMS Rawa u/c GSSS Kareri Distt. Kangra. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GMS Gad u/c GSSS Chowai Distt Kullu to newly upgraded GMS Rawa u/c GSSS Kareri District Kangra against vacancy. The representation of the petitioner is disposed of accordingly.
