ORDER


In the matter of: CWP No. 6223/2022 titled as Sonika Kumari Vs. State of H.P. & Others.

Whereas, Smt. Sonika Kumari, TGT (NM) preferred CWP No. 6223/2022 titled as Sonika Kumari Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Neul Distt. Kullu to the station which is suitable to her in District Mandi. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 7.09.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without advertng to the merits of the case, we deem it appropriate to dispose of the writ petition by directing respondent No. 2 to consider and decide the representation (Annexure P-3), moved by the petitioner expeditiously, in accordance with law, preferably within two weeks from the receipt of the copy of this order."

Whereas, petitioner has submitted her representation Annexure-3 to this office vide which she has requested to adjust her nearby the place of posting of her husband. The vacancy of two school also submitted by her i.e. GHS Bijan Dhalwan Distt. Mandi &GSSS Traimbali Distt. Mandi.


From perusal of record, it has been found that the petitioner has been working at GHS Neul Distt. Kullu since 14.03.2019 and has completed more than three years stay there. One post of TGT(NM) is lying vacant in GSSS Traimbli District Mandi. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and she is hereby transferred without TTA/JT from GHS Neul Distt Kullu to GSSS Traimbli District Mandi against vacancy. The representation of the petitioner is disposed of accordingly.
