ORDER

In the matter of: CWP No. 4966/2022 titled as Ashwani Kumar Vs. State of H.P. & Others.

Whereas, Sh. Ashwani Kumar, TGT (NM) preferred CWP No. 4966/2022 titled as Ashwani Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Saprot u/c GSSS Kohal Distt. Chamba to nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 25.07.2022 when the Hon'ble High Court has passed the following orders:-

" 3. We accede to the request of learned Counsel for the petitioner and accordingly, permit the petitioner to make a fresh representation to respondent No. 2 within one week from today. If such representation is made, the same shall be decided expeditiously by respondent No. 2 and in any even, within six weeks from the date of receipt of the representation.

4. The petitioner to stand disposed of accordingly. Pending miscellaneous application(s), if any, also to stand disposed of."

Whereas, petitioner was submitted his representation to this office on 1.8.2022 vide which he has given five stations of his choice but all these schools have already been filled up. However, the petitioner has submitted a fresh representation to this office on 6.10.2022 vide which he has requested to adjust him at GSSS Makroli/GSSS Rehan/GSSS Golwan against vacancy.

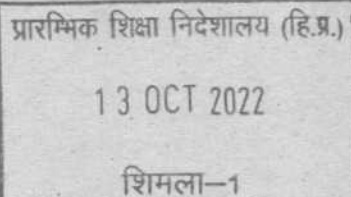
From perusal of record, it has been found that the petitioner has been working at GMS Saprot u/c GSSS Kohal Tehsil Churah Distt. Chamba(hard/sub-cadre area) since 8.3.2019 and has completed more than three years stay there. At present one post of TGT(NM) is lying vacant in GSSS Golwan Distt. Kangra. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GMS Saprot u/c GSSS Kohal Distt Chamba to GSSS Golwan District Kangra against vacancy. The representation of the petitioner is disposed of accordingly.
