OFFICE MEMORANDUM

Subject: Regarding grant of pension allowance @ 5%, 10% & 15% on revised basic pension/ basic family pension.

The undersigned is directed to say that vide this department's Office Memorandum No. Fin(Pen)A(3)-1/09 dated 23rd April, 2014, pension allowance @ 5%, 10% & 15% was granted on basic pension/ family pension to the State Government pensioners/ family pensioners, including AIS pensioners/ family pensioners, on attaining the age of 65 years 70 years and 75 years, respectively. Further, vide Office Memoranda No. Fin(Pen)A(3)-1/09 dated 17th September, 2016 and No. Fin(Pen)A(3)-1/2021 dated 25th February, 2022, pension allowance was ordered to be paid to the AIS pensioners and State Government pensioners respectively, on pre-revised basic pension/ family pension, in the wake of revision of pension & family pension w.e.f. 01.01.2016.

The Governor, Himachal Pradesh is now pleased to decide that Pension Allowance @ 5%, 10% and 15% will be paid with effect from 1st October 2022, on attaining the age of 65 years, 70 years and 75 years respectively on revised pension/ family pension to the Government pensioners/ family pensioners.

These orders will also apply to the All India Services Pensioners/ family pensioners of Himachal Pradesh Cadre.

These instructions may be strictly adhered to by all the Government Departments and Pension Disbursing Authorities. All the Pension Disbursing Authorities (PDA's) are requested to take necessary action, accordingly.

Other terms and conditions for grant of Pension/ Allowance will remain same.


