In the matter : CWP No. 6477/2022 titled as Sonu Kumar,TGT(Med)VS State of H.P. & others.

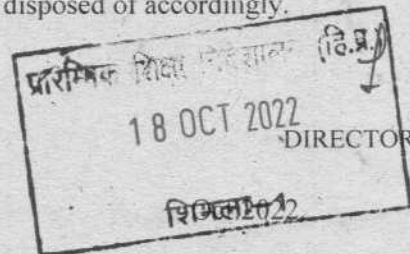

Sonu Kumar,TGT (Med), filed CWP No. 6477/2022titled as, Sonu Kumar,TGT(Med),versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GHS Ramni Dsitt.Kinnaur.(which fall under hard /Tribal area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 15th Sep.2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the fo lwing directions/ order:-

".....In the circumstances,we dispose of this petition by permitting the petitioner to make a representation to respondent No.2.If such a representation is made within one week from today,the same shall be decided within four weeks from today,the same shall be decided within four weeks from the date of receipt of the representation

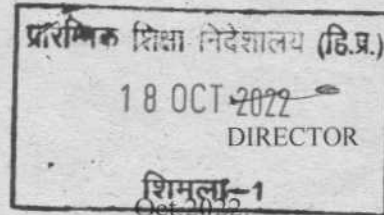
In the matter : CWP No. 5857/2022 titled as Subhash Kumar,TGT(Med)VS State of H.P. & others.

In the matter : CWP No. 6206/2022 titled as Smt. Sonia Chaudhary ,TGT(Med)VS State of H.P. & others.

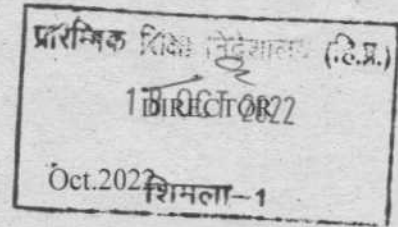
