ORDER

In the matter of: CWP No. 3816 /2022 titled as Vijay Kumar Vs. State of H.P. & Others.

Whereas, Sh Vijay Kumar, TGT (NM) preferred CWP No. 3816/2022 titled as Vijay Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Narayanban u/c GSSS Khani Distt. Mandi to the station near to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27.06.2022 when the Hon'ble High Court has passed the following orders:-

"2. In these circumstances, we dispose of this petition, at this stage, by directing that the representation of the petitioner be decided as expeditiously as possible, preferably within two weeks.

3. Pending miscellaneous applications, if any, shall also stand disposed of accordingly."

Whereas, petitioner has submitted his representation to this office on 6.08.2022 vide which he has given five stations of his choice but posts of TGT(NM) all schools mentioned in the aforesaid representation not lying vacant. However, the petitioner has given fresh representation to this office on 29.9.2022 vide which he has requested to adjust/transfer him at GSSS Nagwain District Mandi against vacancy.

From perusal of record, it has been found that the petitioner has been working at GHS Narayanban u/c GSSS Khani Distt. Mandi since 08.03.2019 and has completed more than three years stay there. At present one post of TGT(NM) is lying vacant in GSSS Nagwain District Mandi. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GHS Narayanban u/c GSSS Khani District Mandi against vacancy. The representation of the petitioner is disposed of accordingly.
