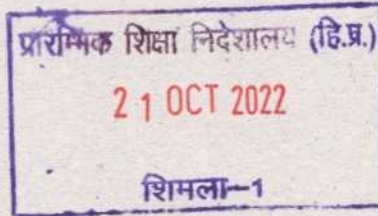
And now keeping in view the position stated above, his representation is considered and he is hereby adjusted at GMS Salwana u/c GSSS Salol District Kangra against vacancy.

ORDER



In the matter of:

CWP No. 5622/2022 titled as Manoj Kumar Vs. State
of H.P. & Others.

Whereas, Sh. Manoj Kumar, TGT (NM) preferred CWP No. 5622/2022 titled as Manoj Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GMS Shivpur u/c GSSS Mubarikpur Distt. Una to GSSS Sarahan Distt. Sirmour vice Sh. Kapil Dev, TGT(NM) & vice-versa. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 12.09.2022 when the Hon'ble High Court has passed the following orders:-

" 6. I the given fact and circumstances of the case, we deem it appropriate to dispose of this peititon by directing respondent No. 2 to consider the reply filed by respondent No. 3 before this Court as as representation on his behalf and thereafter decide the same sympathetically taking into consideration the adverse family circumstances mentioned supra in which respondent No. 3 is placed and take a decision thereupon within a period of 10 days from today and, if possible, order of transfer and posting of respondent No. 3 to anyone of the following stations:-

- (1) GSSS Ghanari District Una
- (2) GSSS Gugdehar(Una)
- (3) GMS Amb u/c GSSS Amb, Una
- (4) GSSS Chowki Maniyar, Una

Ordered Accordingly.

7. *The petitioner is disposed of in the aforesaid terms, so also the pending application, if any.*
8. *However, before parting, it is made clear that this order is being passed in the peculiar facts and circumstances of the instant case and shall not be treated as a precedent in future.*
9. *For compliance, to come up on 27.09.2022."*

Whereas, there was no post of TGT(NM) lying vacant in aforesaid schools. However, the respondent No. 3 has given fresh representation to this office vide which he has given seven stations of his choice in District Una. These all stations have also been filled up. Now, the petitioner has given a latest representation on 17.10.2022 vide which he has given four stations for his adjustment in District Una.

From perusal of record, it has been found that the respondent No. 3 has been working at GSSS Sarahan District Sirmour since 12.9.2018 and has completed more than four years stay. At present one post of TGT(NM) is lying vacant in GMS(G) Amb u/c GMSSS Amb Distt. Una where the respondent No. 3 is also willing for transfer. Keeping in view, the above facts and circumstances, the case of the respondent No. 3 for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Sarahan Distt Sirmour to GMS(G) Amb u/c GMSSS Amb District Una against vacancy. The representation of the petitioner is disposed of accordingly.
