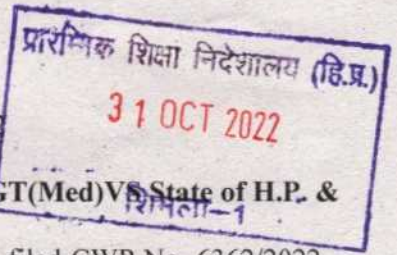

ORDER

In the matter : CWP No. 6362/2022 titled as Samriti Sharma, TGT (Med) VS. State of H.P. & others.


The Petitioner, Smt. Samriti Sharma, TGT (Med), filed CWP No. 6362/2022 titled as Smt. Samriti Sharma, Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Bagi Bhanwas Distt. Mandi (which fall under hard /Tribal area) to her choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 14th Sep.2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

" The learned counsel for the petitioner states that petitioner would make a fresh representation to respondent No2-Director of H.P. Elementary Education Department Shimla, H.P., and requests that direction be issued to decide the same expeditiously.

We acceded to the request of the learned Counsel and direct that if such representation made within one week from today, the same shall be decided by respondent No.2 expeditiously and in any event within four weeks from the date of receipt of the representation."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 27th Oct.2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at GSSS(B) due to superannuation of present incumbent i.e Smt. Meena Bisht, TGT(Med), scheduled on 31st March, 2023.


From the perusal of the record, it reveals that Smt. Samriti Sharma, TGT(Med) has been working in GSSS Bagi Bhanwas Distt. Mandi (which falls under hard /Tribal area) since 14th May.2019 and has completed her normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Bagi Bhanwas Distt. Mandi to GSSS(Boys) Mandi, Distt. Mandi against vacancy being caused due to superannuation of present incumbent. These orders will be implemented after the retirement of present incumbent on 31st March, 2023. With these observations the representation of the petitioner is considered and disposed of accordingly.
