ORDER

In the matter of: CWP No: 6838/2022-Deepak Kashav, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer).

Sh. Deepak Kashav, TGT(Arts) has filed CWP No. 6838/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Hellan, Distt.Mandi . The case was listed on 15.09.2022, when the same has been disposed of with the following orders :-

The respondents to consider and decide the case of the petitioner and thereafter issue consequential orders of transfer of the petitioner to one of the five stations of his choice within a period of four weeks from today.

Pending application (s) if any, also stand disposed of.

For compliance, to come up on 02.11.2022.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner i.e Sh. Deepak Kashav, TGT (Arts) was perused wherein petitioner stated that he is working since 06.07.2019 in GSSS Hellan, Distt.Mandi, which is 200 KM from his native place. He has requested that due to adverse family circumstances he may kindly be transferred from GSSS Hellan, Distt. Mandi to GMS Nadli u/c Haler/ GHS Mungal/ GMS Drumka Kalan/ GSSS Kunsal, Distt.Kangra / GMS Ghatta u/c GSSS Chauntra, Distt.Mandi.

From the perusal of record, it is found that Sh. Deepak Kashav, TGT(Arts) is working in GSSS Hellan, Distt.Mandi since 06.07.2019 and has completed normal tenure at his present place of posting. At present post of TGT(Arts) is lying vacant in GHS Mungal, Distt. Kangra. Keeping in view the position stated above, representation of petitioner i.e Sh. Deepak Kashav, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Hellan, Distt. Mandi to GHS Mungal, Distt. Kangra, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
