The Petitioner Smt.Shruti Chaudhary,TGT (Med), filed CWP No. 6818/2022 titled as Smt. Shruti Chaudhary versus State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Samra, (B.Mehla),Dsitt. Chamba H.P.(which fall under Hard/Tribal area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 27th September,2022,when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

- 4.GSSS Purba Distt. Kangra .
- 5.GSSS Hatli,Dsitt. Chamba

The entire exercise be completed within a period of four weeks from today".

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated.27th October,2022 .The petitioner attended the personal hearing on scheduled date and time.During personal hearing she has requested that she may be adjusted in GSSS Jalot /GHS Nerti/GSSS Boh Distt. Kangra and GSSS Hatli Distt. Chamba agasint vacancy or longer stay. The petitioner has further stated that she is facing some personal difficulties.

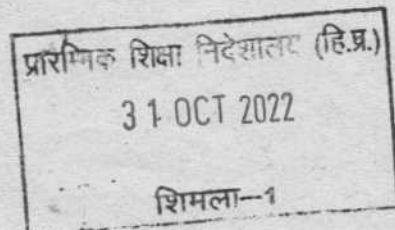
