**ORDER**

**In the matter :**

**CWP No. 6317/2022 titled as Kamal Raj Kapila,  
TGT, (Med) Vs State of H.P. (Regarding transfer)**

The petitioner, Sh. Kamal Raj Kapila, TGT(Med) filed CWP No. 6317/2022 titled as Sh. Kamal Raj Kapila, TGT (Med) versus State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Padhechi u/c GSSS Koti (Mashobra), Distt. Shimla. The case of the petitioner was listed before the Hon'ble High Court, on 18<sup>th</sup> July, 2022 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

*"Accordingly, without adverting to the merits of the case, we deem it appropriate to dispose of the writ petition with a direction to respondent No.2, Director of elementary Education, to dispose of the representation dated 14-03-2022 (Anneure P-2), moved by the petitioner, in accordance with law, within a period of two weeks from the date of receipt of the copy of this order"*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 27-10-2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted at GSSS Bhareri/GHS Kakkar/GSSS Bhukkar/GSSS Jahu distt. Hamirpur and GSSS Amroh/GSSS Hatwar Distt. Bilaspur against vacancy.

The representation has been examined carefully and it has been revealed that Sh. Kamal Raj Kapila, TGT(Med), has been working in GHS Padhechi u/c GSSS Koti Distt. Shimla since 22<sup>nd</sup> September, 2021, as such he has not completed his normal tenure of three years as is required under clause 16(16.1) of "Comprehensive Guiding Principles-2013". Hence, it is not feasible to transfer him at present. With these observations the representation of Sh. Kamal Raj Kapila, TGT(Med) is disposed of and rejected after due consideration. All the concerned be intimated accordingly.

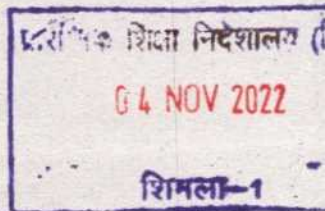

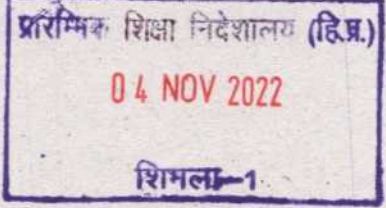

**In the matter :** CWP No. 6849/2022 titled as Madhu Asha ,TGT(Med)VS State of H.P. & others.

The Petitioner,Smt.. Madhu Asha,TGT,(Med),filed CWP No. 6849/2022 titled as, Madhu Asha, versus State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GHS Bakhan (Nirmand) u/c GSSS Kaharga 15/20 ,Distt. Kullu. (which falls under hard /Tribal area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 28<sup>th</sup> Sep.2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following order:-

*"Accordingly,without advertng to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation despondent N.2 in terms of the Transfer policy,dated 10<sup>th</sup> July 2013,within a week from today.then respondent No. 2 shall dispose of the same within two weeks from the date of receipt of the representation alongwith copy of this order,in accordance with law."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 27<sup>th</sup> October,2022, but he could not attend the same.The petitioner has submitted her representation to the undersigned ,in which she has requested that she may be adjusted at GSSS Bashing /GHS Mashna,Distt. Kullu agasint vacancy or Newly upgraded school in Distt. Kullu.

From the perusal of the record, it reveals that Smt.Madhu Asha,TGT(Med), has been working in GHS Bakhan u/c GSSS Kharga 15/20 Distt. Kullu(Which falls under hard /Tribal area), since 05<sup>th</sup> May:2022 and has not completed her normal tenure at present place of posting. Hence, it is not feasible to transfer him at present. With these observation the representation of Smt. Madhu Asha,TGT(Med) is disposed of and rejected after due consideration.



Kangra against vacancy.

From the perusal of the record, it reveals that Smt. Priyanka Kumari,TGT(Med) has been working in GSSS Ather(Salooni) Distt. Chamba since 12<sup>th</sup> March,2019, and has completed her normal tenure at present place of posting. 
