ORDER

In the matter of: CWP No. 5955/2022 titled as Vipin Kumar Vs. State of H.P. & Others.

Whereas, Sh. Vipin Kumar, TGT (NM) preferred CWP No. 5955/2022 titled as Vipin Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Devgarh District Shimla to the station nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 31.08.2022 when the Hon'ble High Court has passed the following orders:-

" 2. In these circumstances, we dispose of this petition by permitting the petitioner to make a fresh representation to respondent No. 2-the Director Elementary Education, Himachal Pradesh. If such representation is made within three days from today, the same shall be decided expeditiously, and in any event, within three weeks from the date of receipt of the representation.

3. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

Whereas, petitioner was submitted his representation to this office on 5.9.2022 vide which he has requested that her wife is also working as TGT(Arts) in GMS Khabbal u/c GSSS Nagrota Surian District Kangra and being a couple case he may also be transferred to District Kangra. He has given nine stations of his choice but all these schools are filled up. The petitioner has given latest representation to this office on 14.10.2022 vide which he has requested to adjust/transfer him at GHS Mao District Kangra against vacancy.

From perusal of record, it has been found that the petitioner has been working at GSSS Devgarh Distt. Shimla since Oct, 2017 and has completed five years stay. At present one post of TGT(NM) is lying vacant in GHS Mao District Kangra. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Devgarh Distt Shimla to GHS Mao District Kangra against vacancy. The representation of the petitioner is disposed of accordingly.
