ORDER

In the matter of: CWP No. 4501/2022 titled as Sunita Devi Vs. State of H.P. & Others.

Whereas, Smt. Sunita Devi, TGT (NM) preferred CWP No. 4501/2022 titled as Sunita Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Doghari District Mandi to the station of her choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 8.07.2022 when the Hon'ble High Court has passed the following orders:-

" 3. In view of the aforesaid statement, we dispose of the writ petition by directing respondent No. 2/Director, Elementary Education, Shimla H.P. Education Directorate, Shimla, to consider and decide the representation of the petitioner (Annexure P-3) expeditiously and in any event within three weeks from today. "

Whereas, petitioner was submitted her fresh representation to this office on 16.07.2022 vide which she has not given any station of her choice for transfer. However, the petitioner has submitted again a representation to this office vide which she has requested that she may be adjusted/transferred in the station of choice i.e. GHS Nareli District Hamirpur against vacancy being caused due to promotion of present incumbent.

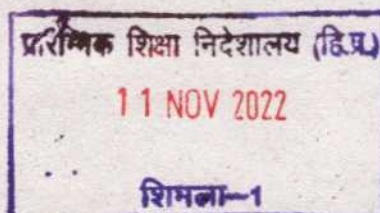
From perusal of record, it has been found that the petitioner has been working at GSSS Doghari Distt. Mandi since the year, 2018 and has completed four years stay there. Keeping in view, the above facts and circumstances, the representation of the petitioner is considered sympathetically and she is hereby transferred without TTA/JT from GSSS Doghari Distt Mandi to GHS Nareli District Hamirpur against vacancy being casued vacant due to promotion of present incumbent. These orders will be implemented after the relieving of the present incumbent on promotion. The representation of the petitioner is disposed of accordingly.
