

**ORDER**

In the matter of: CWP No: 6286/2022-Khushal Singh, TGT (Arts) Vs. State of Himachal Pradesh (Regarding Transfer).

Sh. Khushal Singh, TGT(Arts) has filed CWP No. 6286/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Rai, Distt.Chamba .The case was listed on 28.10.2022, when the same has been disposed of with the following orders :-

*The petitioner to file a representation clearly setting out therein five stations of his choice, out of which one should be out of home district, within a period of one week from today. Thereafter, the respondents shall consider and decide the same and pass consequential orders of his transfer within three weeks on receipt of such representation. Pending application (s), if any, also stands disposed of.*

*For compliance, to come up on 25.11.2022.*

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner has submitted representation, vide which he stated that as per clause 16.1 of the Comprehensive Guiding Principles 2013, he has completed normal tenure i.e two winters and three summers in GSSS Rai (Pangi) Distt.Chamba. He has requested that he may be transferred from GSSS Rai, Distt.Chamba to GSSS Fatehpur/ GMS Kangreri u/c GSSS Makroli/ GSSS Rey/GSSS Praal/ GSSS (Girls) Rehan, Distt.Kangra.

From the perusal of record, it is found that Sh. Khushal Singh, TGT(Arts) is working in GSSS Rai (Tribal) Distt.Chamba since 04.12.19 and has completed two winters and three summers at his present place of posting. At present post of TGT (Arts) is lying vacant in GSSS Fatehpur, Distt. Kangra. Keeping in view the position stated above, representation of petitioner i.e Sh. Khushal Singh, TGT (Arts) is considered sympathetically and he is hereby transferred from GSSS Rai, Distt.Chamba to GSSS Fatehpur, Distt.Kangra, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
