ORDER

In the matter of: CWP No : 5946/2022-titled as Mohinder Singh & another Vs. State of Himachal Pradesh & others.

Smt. Meeran Devi, TGT (Arts) has filed CWP No. 5946/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Khamadi, Distt. Shimla. The case was listed on 31st August, 2022, when the same has been disposed of with the following orders :-

" The petitioners to make fresh joint representation to respondent No.2. If such representation is made within three days from today, the same shall be decided expeditiously, and in any event, within two weeks from the date of receipt of the representation.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application (s), if any."

In compliance to the aforesaid order/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Smt. Meeran Devi, TGT (Arts) was called for personal hearing and appeared before the undersigned on dated 11.11.2022. At the time of personal hearing she has submitted representation vide which she stated that she is working in GSSS, Khamadi, Distt.Shimla since 04.09.2018 and requested that due to adverse family circumstances she may kindly be transferred from GSSS Khamadi, Distt.Shimla to GMS Sudar u/c GSSS Dhangota / GSSS Dhangota/ GSSS Pairwin/ GSSS Samtana, Distt.Hamirpur/ GHS Taraun, Distt.Bilaspur:

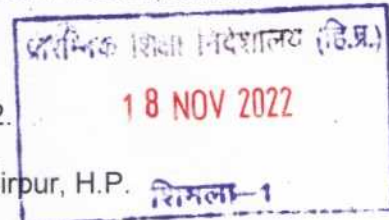
From the perusal of record, it is found that Smt. Meeran Devi, TGT(Arts) is working in GSSS Khamadi, Distt.Shimla since 04.09.2018 and has completed normal tenure at his present place of posting. One post of TGT (Arts) is going to be vacant at GMS Sudar u/c GSSS Dhangota, Distt.Hamirpur, due to retirement of present incumbent. Keeping in view the position stated above, representation of petitioner i.e Smt. Meeran Devi, TGT(Arts) is considered sympathetically and she is hereby transferred from GSSS Khamadi, Distt.Shimla to GMS Sudar u/c GSSS Dhangota, Distt.Hamirpur, against vacancy, being caused due to retirement of present incumbent on 30.11.2022, without TTA/JT. The petitioner will join after superannuation of present incumbent i.e. after 30.11.2022. The representation of the petitioner is disposed of accordingly.
