**ORDER**

In the matter of: CWP No : 7624/2022-Jai Pal, TGT (Arts) Vs. State of Himachal Pradesh  
(Regarding Transfer).

Sh. Jai Pal, TGT (Arts) has filed CWP No. 7624/2022-before the Hon'ble High Court of H.P. regarding transfer from GHS Nathpa, Distt. Kinnaur. The case was listed on 01.11.2022, when the same has been disposed of with the following orders :-

2. " The petitioner admittedly has completed his normal tenure in the tribal area i.e Government High School, Nathpa, Tehsil Nichar, District Kinnaur, H.P. Once that be so, he is definitely entitled to be posted in a soft area in terms of Comprehensive Guiding Principles-2013 regarding the transfer of State Government employees."

3. The petitioner has given following stations of his choice:-

- GSSS Nakhlehra District Bilaspur, H.P.
- GSSS Jhandutta District Bilaspur, H.P. (falling vacant on 30.11.2022 on superannuation).
- GHS Chhamba-Dhujwan District Bllaspur, H.P.
- GSSS Baha District Solan, H.P.
- GHS Naina Devi Ji District Bilaspur, H.P.

4. The respondents to consider the case of the petitioner for his posting in any one of the aforesaid stations and issue consequential orders within a period of three weeks from today. Pending applications, if any, also stand disposed of."

For compliance, to come up on 22<sup>nd</sup> November 2022.

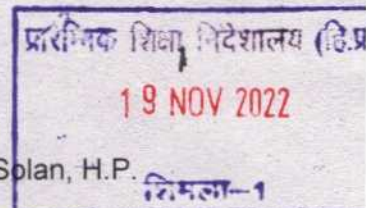

Post of TGT (Arts) is lying vacant in GSSS Baha, Distt.Solan. Keeping in view the position stated above, representation of petitioner i.e Sh. Jai Pal, TGT (Arts) is considered sympathetically and he is hereby transferred from GHS Nathpa, Distt. Kinnaur to GSSS Baha, Distt. Solan, against vacancy. The representation of the petitioner is disposed of accordingly.
