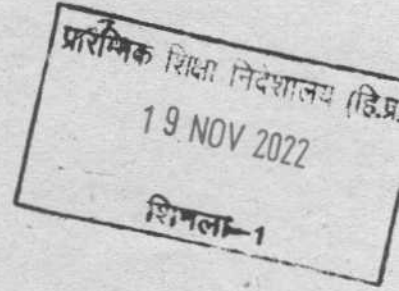

In this context, you are requested to issue necessary instructions to all BEEO's, CHT's and schools to ensure 100% registration of all students on "Mukhya Mantri Bal Suposhan Yojan" (MMBSY) Mobile App in a time bound manner as well as before the visit of National Health Mission team for anemia test of students in respective schools. Thereafter, the anemia test reports of all students will be entered in the "MMBSY" Mobile App on the day of anemia testing.

In this regard, you are further requested to ensure 100% screening of all students for Anemia test and also ensure the entries of all anemia tested students in the MMBSY Mobile App on priority at school level. Moreover, the said task may be followed with the Blocks, CHTs & Schools on day to day basis being a time bound flagship programme/ campaign of the State Government.
