ORDER

In the matter : CWP No. 6080/2022 titled as Chandan Guleria,TGT(Med)VS State of H.P. & others.

The Petitioner,Sh. Chandan Guleria,TGT (Med), filed CWP No. 6080/2022 titled as, Chandan Guleria,TGT(Med),versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Gadagusain (Balichowki) Dsitt. Mandi (which falls under hard /Tribal area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 02nd Sep.2022, when after hearing the matter,the Hon'ble High Court has disposed of the same with the following directions/ order:-

" In the circumstances ,we dispose of the petition by permitting the petitioner to make a fresh representation to respondent No.2 within a period of one week from today.If such representation is made,the same shall be decided by respondent No,2 not later than six weeks from the date of receipt of the representation.The pending application (s) if any,alsoto stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 27th Oct.2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted at GSSS(Boys)Mandi/ GHS Khalanoo/ GSSS Shartee/ GSSS Shivabadar/ GHS Dugrain Dsitt. Mandi against vacancy or longer stay.

From the perusal of the record,it reveals that Sh.Chandan Guleria ,TGT(Med), has been working in GSSS Gadagusain,(Balichowki) Distt. Mandi (Which falls under hard /Tribal area), since 08th March.2019 and has completed his normal tenure at present place of posting. Hence, the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Gadagusain, (Balichowki) Distt.Mandi to GHS Khalanoo Dsitt.Mandi, without TTA/JT vice Smt. Monika, TGT,(Med), with TTA/JT.With these observations the representation of the petitioner is considered and disposed of accordingly.
