ORDER

In the matter :

CWP No. 5772/2022 titled as Lata Devi,TGT,(Med)
State of H.P. (Regarding transfer)

The petitioner,Smt. Lata Devi,TGT(Med) filed CWP No.5772/2022 titled as Smt. Lata Devi,TGT(Med)versus State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS Belardhar u/c GSSS Sorshan (Karsog) Distt. Mandi.The case of the petitioner was listed before the Hon'ble High Court, on 25th August,2022 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

" The petitioner is seeking transfer from her present place of posting at GHS Belardhar Tehsil Karsog Distt. Mandi ,which is a difficult area.It is the case of the petitioner that on completion of the normal tenure,she is entitled to be transferred to the station of her choice in terms of para 5.2 of the transfer policy ,which provide for concession to the wives of soldiers .It is pointed out that the petitioner has made a representation dated 07-08-2022(Annexure P-1)to respondent No.2 Diretor Elementary Education ,Himachal Pradesh.

We,therefore,dispose of this petition by directing respondent No.2 to decide the representation of the petitioner (Annexure P-1) expeditiously and in any event,within four weeks from today .

The writ petition to stand disposed of in the above terms,so also the pending miscellaneous application(s),if any."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 21-11-2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at BRCC Sadar-2/GSSS Kotsnore Distt. Mandi.The petitioner has further stated that her husband is working in the Indian Army and is presently posted at Srinagar (J&K) .As such there is no one of the family to look after the old and ailing mother –in –law and two minor children.

The representation has been examined carefully and it has been revealed that Smt.Lata Devi,TGT(Med), has been working in GHS Belardhar u/c GSSS Sorshan Distt. Mandi since 30th March,2019,as such she has completed her normal tenure of three years. Hence, the representation of the petitioner is considered sympathetically and she is hereby transferred from GHS Belardhar Distt. Mandi to GSSS Kotsnore Distt. Mandi against vacancy.With these observations, the representation of the petitioner is considered and disposed of accordingly .
