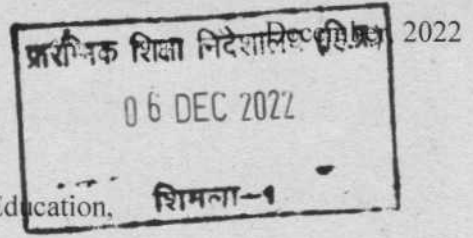


Subject: Regarding regularisation of the service of contract Appointees appointed on dated 29.09.2017 and joined after 2nd October, 2017.

Sir,

On the subject cited above, it is to inform you that the Government has taken the decision vide letter No. PER(AP)-C-B(2)-1/2019 dated 06.04.2022 that in order to remove the hardship being faced by the individuals due to maximal restriction, which deprives to give joining due to holidays immediately after issuance of appointment order, it has been decided by the Government to condone the period of holidays only in such cases where the offer/order of appointment is made/issued on the last working day of the month of March or September, as the case may be, and holiday(s) falling immediately thereafter restricting the incumbent to give joining in that particular month of appointment. The date of issuance of offer/order of appointment will be reckoned as cutoff date for their regularisation and such period and joining time shall be considered as condoned inter-se.


