**ORDER**

**In the matter :** CWP No. 6174 /2022 titled as Bhima Devi,TGT,(Med)VS State of H.P. & others.

The Petitioner,Smt. Bhima Devi ,TGT (Med), filed CWP No. 6174/2022 titled as, Smt. Bhima Devi,TGT(Med), Vs State of H.P. before the Hon'ble High Court of H.P.regarding her transfer from GSSS Sarni (MND).(which fall under hard /Tribal area) to her choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 06<sup>th</sup> Sep.2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"Without going into the merits of the case ,we dispose of the present writ petition by permitting the petitioner to make a fresh representation to respondent No.2 Director Elementary Education Himachal Pradesh.If such representation is made within on week,the same shall be decided expeditiously and in any event,within four weeks from the date of receipt of the representation."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 10<sup>th</sup> Oct.2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at GSSS Chailchowk /GHS Dhaban u/c GSSS Lohara/GHS Dugrain u/c GSSS Rajwari GSSS Saraunjh Distt. Mandi against vacancy/longer stayee.

From the perusal of the record, it reveals that Smt. Bhima Devi,TGT(Med), has been working in GSSS Sarni Distt. Mandi, since 12<sup>th</sup> March,2019 and has completed her normal tenure at present place of posting. Hence,the representation of the petitioner is considered sympathetically and she is hereby transferred from GSSS Sarni(MND) to GSSS Saraunjh Distt. Mandi without TTA/JT vice Smt. Vandana ,TGT(Med), with TTA/JT.With these observations the representation of the petitioner is considered and disposed of accordingly.
