ORDER

In the matter of: CWP No : 7944/2022-titled as Rajnish Nadda Vs. State of Himachal Pradesh & others.

Smt. Rajnish Nadda, TGT (Arts) has filed CWP No. 7944/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Kholanal, Distt.Mandi. The case was listed on 16th November 2022, when the Hon'ble High Court has passed the following order :-

The petitioner moves a fresh representation to respondent No.2, in terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondent No.2 shall dispose of the same within two weeks of the receipt of the representation, in accordance with law.

Pending application (s), if any, shall also stand disposed of.

To come up for compliance on 28th December, 2022.

In compliance to the aforesaid order/ judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner has submitted her representation vide which she stated that she has completed her normal tenure in GSSS Kholanal, which is difficult area of Distt. Mandi. She has further stated that her husband is working as TGT (NM) in GSSS Kasmaila.(Mandi) and mother in-law is 86 years old suffering from various old age ailments. She has requested that due to adverse family circumstances she may kindly be transferred from GSSS Kholanal, Distt. Mandi to GSSS Nalti/GHS Pantehra (Bilaspur)/ GHS Kalthar/GMS Nagrota u/c GSSS Baldwar/GHS Kehri u/c GSSS Baldwara, Distt.Mandi.

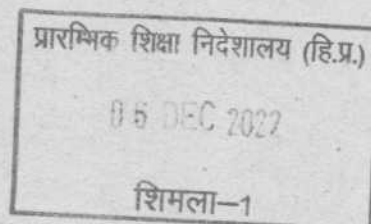
From the perusal of record, it is found that Smt. Rajnish Nadda, TGT (Arts) is working in GSSS Kholanal, Distt. Mandi since 06.10.17 and has completed normal tenure at the present place of posting. At present one post of TGT (Arts) is lying vacant at GHS Kalthar, Distt.Mandi. Keeping in view the position stated above, representation of petitioner i.e Smt. Rajnish Nadda, TGT (Arts) is considered sympathetically and she is hereby transferred from GSSS Kholanal, Distt.Mandi to GHS Kalthar, Distt.Mandi, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

ORDER

In the matter of: CWP No : 7806 / 2022- Ajay Kumar Vs. State of Himachal Pradesh & others.

Sh. Ajay Kumar, TGT(Arts) has filed CWP No. 7806/2022-before the Hon'ble High Court of H.P. regarding transfer from GHS Tarswan u/c GSSS Dharmehar, Distt. Mandi. The case was listed on 09.11.2022, when the Hon'ble High Court has passed the following order :-

" The petitioner has completed his normal tenure of service in the difficult /sub cadre area having been posted at GHS Tarswan u/c GSSS Dharmehar (Chuhar Ghatti), District Mandi, H.P, since 19.08.2019, thus, he is entitled to be transferred to one of the soft stations of his choice in terms of the Comprehensive Guiding Principles-2013.

For this purpose, the petitioner has already set out five stations of his choice, as enumerated in para-5 of the petition, which reads as under:-

- i) GMSSS (Girls) Joginder Nagar, District Mandi, H.P (against vacancy)
- ii) GSSS Tikroo(against longer stay)
- iii) GSSS Khuddar
- iv) GSSS Harabhag
- v) GSSS Bir, District Kangra, H.P

Consequently, we deem it appropriate to dispose of the petition by directing the respondents to consider and decide the case of the petitioner and thereafter issue necessary consequential order of transfer of the petitioner to any one of the five stations of his choice within a four weeks from today. Ordered accordingly. Pending miscellaneous application(s),if any, also stand disposed of.

Now to come up for compliance on 07.12.2022."

In compliance to the aforesaid order/ judgment passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner was perused and found that Sh. Ajay Kumar, TGT (Arts) is working in GHS Tarswan, Distt.Mandi (Sub Cadre) since 19.08.2019 and has completed normal tenure at his present place of posting. Sh. Dina Nath, TGT (Arts) is working in GSSS Tikroo, District Mandi since 21.09.2019 and has completed normal tenure at his present place of posting. Keeping in view the position stated above, representation of petitioner i.e Sh. Ajay Kumar, TGT (Arts) is considered sympathetically and he is hereby transferred from GHS Tarswan, District Mandi to GSSS Tikroo, District Mandi vice Sh. Dina Nath, TGT (Arts) and vice versa with TTA/JT to Sh. Dina Nath, TGT (Arts). The representation of the petitioner is disposed of accordingly.
