ORDER

In the matter of: CWP No : 7815/2022- Subhash Chand, TGT (Arts) Vs. State of Himachal Pradesh & others.

Sh. Subhash Chand, TGT(Arts) has filed CWP No. 7815/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Bagi Bhanwas, Distt.Mandi. The case was listed on 10.11.2022, when the Hon'ble High Court has passed the following order :-

" The respondent No.2, Director of Elementary Education, Himachal Pradesh, to dispose of the representation of the petitioner dated 22.06.22 (Annexure P-2) in accordance with law, within a period of two weeks from the date of receipt of the copy of this order. Pending miscellaneous application(s), if any, also stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the representation filed by the petitioner was perused wherein the petitioner i.e Sh. Subhash Chand, TGT (Arts) stated that he has completed normal tenure at GSSS Bagi Bhanwas, District Mandi which is a most difficult area. He has requested that due to adverse family circumstances he may kindly be transferred from GSSS Bagi Bhanwas, District Mandi to GHS Futakhal u/c GSSS Jhatingri/ GSSS (Girls) Joginder Nagar (Mandi) GSSS Chukku/ GSSS Tikru, District Mandi.

From the perusal of record, it is found that Sh. Subhash Chand, TGT (Arts) is working in GSSS Bagi Bhanwas, District Mandi since 18.01.2019 and has completed normal tenure at his present place of posting. At present post of TGT(Arts) is lying vacant at GSSS (Girls) Joginder Nagar, District Mandi. Keeping in view the position stated above, representation of petitioner i.e Sh. Subhash Chand, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Bagi Bhanwas, District Mandi to GSSS (Girls) Joginder Nagar, District Mandi, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
