**ORDER**

In the matter of: CWP No. 8138/2022 titled as Varun Kumar Vs. State of H.P. & Others.

Whereas, Sh. Varun Kumar, TGT (NM) preferred CWP No. 8138/2022 titled as Varun Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Uchka u/c GSSS Lylh District Chamba to the station nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 24.11.2022 when the Hon'ble High Court has passed the following orders:-


*" 3. A perusal of the petition would go to show that the petitioner has completed his normal tenure of service in tribal area. Therefore, he is entitled to be transferred from the tribal area to a soft area, that too a station of his choice, in terms of the transfer policy/guidelines framed by the Government in this regard. The petitioner has given five stations of his choice in paragraph-6 of instant petition, which are enumerated as under:-*

- a. GHS Haler Kalan under complex GSSS New Kangra, H.P.*
- b. GMS Bhalundar u/c Lahru (Alampur) District Kangra.*
- c. GSSS Ranital, District Kangra, H.P.*
- d. GSSS Rajiana Bandh District Kangra, H.P.*
- e. GSSS Hamirpur, District Hamirpur.*

*4. In this view of the matter, we dispose of this petition with a direction to the respondents-State to consider the case of the petitioner and thereafter consequential order of transfer be passed, positively within a period of two weeks from today.*

*5. Pending application, if any, also stands disposed of."*

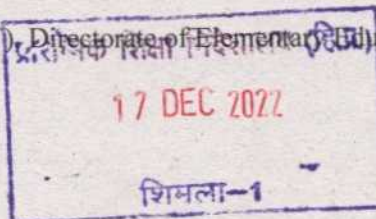



Whereas, Sh. Arun Kumar, TGT (NM) preferred CWP No. 8173/2022 titled as Arun Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Digwa u/c GSSS Millah District Sirmour to the station nearby her native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 25.11.2022 when the Hon'ble High Court has passed the following orders:-

*" 3. Since, the petitioner has completed his normal tenure of service in the difficult/sub-cadre area having been posted at Government High School Digwan u/c GSSS Millah Education Block Bakras, District Sirmour, H.P. thus he is entitled to be transferred to one of the soft stations of his choice in terms of the comprehensive Guiding Principles-2013.*


*4. For this purpose, the petitioner has already set out five stations of his choice, as enumerated in para-6(C) of the petition, which reads as under:-*

- i) GSSS Sailkar (Kangra)*
- ii) GHS Harot (Una)*
- iii) GMS Fegal u/c GSSS Pressi Distt. Mandi*
- iv) GSSS Jowar (Una)*
- v) GSSS Nehrian (Una)*

*5. Consequently, we deem it appropriate to dispose of this petition by directing respondents No. 2 to consider and decide the case of the petitioner and thereafter issue necessary consequential order of transfer of the petitioner to any one of the five stations of his choice within a period of four weeks from today. Ordered accordingly. Pending miscellaneous application(s), if any, also stand disposed of.*

*6. Now to come up for compliance on 23.12.2022."*

Mandi against vacancy. The representation of the petitioner is disposed of accordingly.

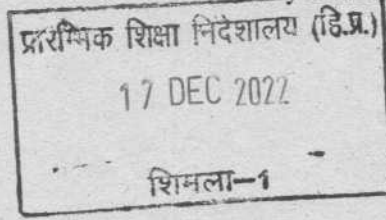
