ORDER

In the matter of: CWP No. 4008/2022 titled as Brajeshwari Kashyap Vs. State of H.P. & Others.

Whereas, Smt. Brajeshwari Kashyap, TGT (NM) preferred CWP No. 4008/2022 titled as Brajeshwari Kashyap Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Guwar u/c GSSS Guwan District Chamba to the station nearby her native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 23.06.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without adverting to the merits of the case, this petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, if terms of the transfer policy, dated 10th July, 2013, within a week from today, then respondents shall dispose of the same within two weeks of the receipt of the representation, in accordance with law. Pending application(s), if any, also stand disposed of."

Whereas, the petitioner has given her representation to this office on 12.8.2022 vide which she has given five stations of her choice but all these stations had already been filled up. However, the petitioner was called for personal hearing on 23.09.2022 when she has given a fresh representation regarding her transfer vide which she has requested to transfer her at GSSS Ghaniara District Kangra/GMS Bharanta u/c GSSS Thural District Kangra.

From perusal of record, it has been found that the petitioner has been working at GMS Guwar u/c GSSS Guwan District Chamba(hard/sub-cadre area) w.e.f. 11.03.2019 and has completed more than three years stay. At present there is no post of TGT(NM), lying vacant in the aforesaid schools and incumbent working in GSSS Ghaniara District Kangra having short stay. However, one Shri Arvind Kumar, TGT(NM) is working in GMS Sai Bharanta u/c GSSS Thural District Kangra w.e.f. 20.7.2018 and has completed more than three years stay at his present place of posting. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and she is hereby transferred without TTA/JT from GMS Guwar u/c GSSS Guwan Distt Chamba to GMS Sai Bharanta u/c GSSS Thural District Kangra vice Shri Arvind Kumar, TGT(NM) & vice-versa with TTA/JT to Shri Arvind Kumar. The representation of the petitioner is disposed of accordingly.
