The Petitioner,Sh.Dreemy,TGT(Med), filed CWP No. 8267/2022 titled as, Dreemy versus State of H.P. before the Hon'ble High Court of H.P. regarding his transfer after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 29th Nov.2022 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

In the given facts and circumstances of the case ,we deem it appropriate to dispose of this petition by directing the respondents-State to consider and decide the representation dated 17-09-2022(Annexure P-1) made by the petitioner for his transfer within a period of four weeks Pending application(s),if any also stands when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order:

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on 06-12-2022.The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that he may be adjusted in GSSS Purba /GSSS Bhanala/GSSS Nadholi/GSSS Tatehal District Kangra /GSSS Talla Distt. Chamba against longer stay. He has also further stated that he is suffering from chronic pancreatitis and get treatment from PGIMER Chandigarh and her wife also working in GSSS Daroh Dsitt. Kangra.

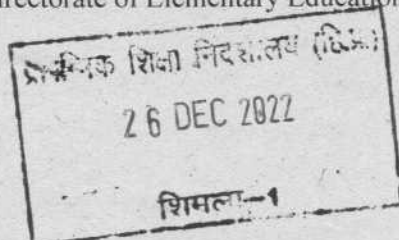
From the perusal of record, it has been noticed that the petitioner is working in GSSS Chanair Distt.Shimla since 31st May 2019 and has completed his normal tenure at present place of posting. It has been clearly mentioned in transfer policy at Clause No.5.4, that in case wife and husband both are working under the State government effort should be made to post them at one place or near places as far as possible. Keeping in view the representation of the petitioner is considered sympathetically and he is hereby transferred from GSSS Chanair Distt Shimla to GHS Talla Distt. Chamba against longer stayee i.e Smt.Nishu,TGT(Med) with TTA/JT. With these observations, the representation of the petitioner is considered and disposed of accordingly .
