ORDER

In the matter of:

CWP No. 8130/2022 titled as Niukt Bhardwaj Vs. State of H.P. & Others.

Whereas, Sh. Niukt Bhardwaj, TGT (NM) preferred CWP No. 8130/2022 titled as Niukt Bhardwaj Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Tatrog u/c GSSS Tissa District Chamba(hard/sub-cadre area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 24.11.2022 when the Hon'ble High Court has passed the following orders:-

" 3. Records reveals that the petitioner has been serving in the hard area of Tissa ever since his first appointment on 15.11.2019 and has completed his normal tenure of service in the hard area. Therefore, in terms of comprehensive guiding principles-2013, he is entitled to be posted at one of the stations of his choice, which are enumerated as under:-

- Govt. Middle School Lot u/c Govt. Sr. Sec. School Utarala District Kangra H.P. (newly upgraded school).
- Govt. Model Sr. Sec. School Majhera, District Kangra, H.P. (Vacant)
- Govt. Sr. Sec. School Ropari Kalehru, District Mandi, H.P.
- Govt. Middle School Harot u/c Govt. Model Sr. Sec. School, Jaisinghpur, District Kangra, H.P.
- Govt. Middle School Ghorav, u/c Govt. Sr. Sec. School Nagrota Bagwan, District Kangra, H.P.

4. Accordingly, in the instant petition is disposed of with a direction to the respondents to consider, decide and thereafter issue consequential orders of transfer of the petitioner to any of the aforesaid stations, within three weeks, without insisting upon joining of the substitute. Pending application(s), if any, also stands disposed of."

5. For compliance, list on 22.12.2022.

From perusal of record, it has been found that the petitioner has been working at GMS Tatrog u/c GSSS Tissa District Chamba(hard/sub-cadre area) w.e.f. 15.11.2019 and has completed more than three years stay. At present one post of TGT(NM) is lying vacant in GSSS Ropari Kalehru District Mandi. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GMS Tatrog u/c GSSS Tissa Distt Chamba to GSSS Ropari Kalehru District Mandi against vacancy. The representation of the petitioner is disposed of accordingly.
