ORDER

In the matter of: CWP No. 7927/2022 titled as Sanjeev Kumar Vs. State of H.P. & Others.

Whereas, Sh. Sanjeev Kumar, TGT (NM) preferred CWP No. 7927/2022 titled as Sanjeev Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Maithly u/c GSSS Ser Tandula Tehsil Sangrah District Sirmour (hard/sub-cadre area) to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 15.11.2022 when the Hon'ble High Court has passed the following orders:-

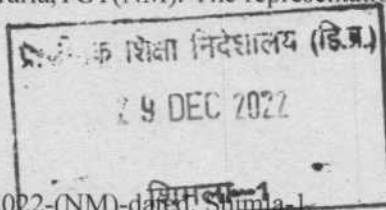
" It is the case of the petitioner that he has completed his normal tenure at the present place of posting at GSSS Ser Tandula, Tehsil Nauhra Dhar, Education Block Sangrah, District Sirmour, H.P. and he is eligible for transfer under the State Government policy dated 3rd October, 2016. Learned counsel for the petitioner states that the petitioner shall make a fresh representation (notiwith standing the earlier representation made by him) for transfer, giving five stations of choice.

2. In such circumstances, we dispose of this petition by permitting the petitioner to make a representation to the respondent No. 2-the Director Elementary Education, Himachal Pradesh. If such representation is made within one week from today, the same shall be decided by respondent No. 2, not later than four weeks from the date of receipt of the representation.

3. The writ petition to stand disposed of in the above terms, so also the pending miscellaneous application(s), if any."

Whereas, petitioner has submitted his representation in this office on 19.11.2022 wherein he has requested to adjust him at the station of his choice i.e. (i) GSSS Kalruhi Distt. Una (ii) GMS Badhiakher u/c GSSS Bahadpur Distt. Kangra (iii) GSSS Jakhera Distt. Una (iv) GSSS Sansarpur Terrace Distt. Kangra (v) GHS Upper Bhalwal Kangra (vi) GHS Deoli District Una.

From perusal of record, it has been found that the petitioner has been working at GMS Maithly u/c GSSS Ser Tandula District Sirmour (hard/Sub-cadre area) since 14.11.2019 and has completed three years stay. One Smt Meenakshi Bhararia, TGT(NM) is working in GSSS Sansarpur Terrace District Kangra since 14.5.2015 and has completed more than seven years stay and has never served in hard/sub-cadre area. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GMS Maithly u/c GSSS Ser Tandula Distt. Sirmour to GSSS Sansarpur Terrance District Kangra vice Smt. Meenakshi Bhararia & vice-versa, with TTA/JT to Smt. Meenakshi Bhararia, TGT(NM). The representation of the petitioner is disposed of accordingly.
