ORDER

In the matter of: CWP No. 7488/2022 titled as Rakesh Kumar Vs. State
of H.P. & Others.

Whereas, Sh. Rakesh Kumar, TGT (NM) preferred CWP No. 7428/2022 titled as Rakesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Koon u/c GSSS Kujabalh District Mandi to the station near to his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 21.10.2022 when the Hon'ble High Court has passed the following orders:-

" 2. Learned counsel for the petitioner has submitted that presently, petitioner is working at Government High School, Koon, District Mandi as Trained Graduate Teacher. Wife of the petitioner is working as Junior Basis Teacher at Government Primary School, Kuthehar, District Mandi. Petitioner had moved a representation Annexure P-1, to respondent No. 2 for his adjustment to a station near the station of posting of his wife, being couple case, in terms of the transfer policy dated 10th July, 2013. However, no action has been taken on the same so far. At this stage, petitioner would be satisfied in case respondent No. 2 is directed to dispose of the representation Annexure P-1, in a time bound manner.

*3. Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction to respondent No. 2 to consider and dispose of the representation Annexure P-1, moved by the petitioner, expeditiously, in accordance with law, preferably within two weeks from the receipt of copy of this order.
Pending application(s), if any, also stand disposed of."*

Whereas, petitioner has submitted his representation in this office on 1.11.2022 wherein he has requested to adjust him at the station of near by the place of posting of his wife as she is working as Junior Basis Teacher in same department. He has given five stations of his choice i.e. (i) GHS Reur Distt. Mandi (ii) GMS Jodhan u/c GSSS Bharari Distt. Mandi (iii) GHS Nalyana Distt. Mandi (iv) GSSS Jhangi Distt. Mandi (v) GHS Cholangarh Distt. Mandi (vi) GBSSS Bilaspur District Bilaspur.

From perusal of record, it has been found that the petitioner has been working at GHS Koon u/c GSSS Kujabalh District Mandi w.e.f. 30.07.2019 and has completed more than three years stay. One post of TGT(NM) is lying vacant in GHS Cholangarh District Mandi. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GHS Koon u/c GSSS Kujabalh Distt. Mandi to GHS Cholangarh District Mandi against vacancy. The representation of the petitioner is disposed of accordingly.
