Regarding pay fixation in r/o Junior Assistant

With reference to the subject cited above, it has been found that, the pay fixation being proposed in pre revised pay scale in r/o the officials placed as Junior Assistant e.g 11560+3200 to 11560+3600 and opted for 15% enhancement in HPCS(RP)Rules for revised pay scale from the date of placement and reaches to 37700 in Level-7, On the other hand the pay fixation being proposed in the revised Pay scale of those incumbent who have opted for 15% enhancement in HPCS(RP)Rules 2022 prior to their placement as Junior Assistant and in such cases pay generally reaches to 36600 in Level-7. Since the Clarification regarding opting revision of pay in HPCS(RP)Rules 2022 from date of placement was issued by state govt. later on. The pay fixations as Junior Asstt. already issued by this Directorate in HPCS(RP)Rules 2022 are being referred back for fixation in pre-revised scales or vice-versa.

Your attention is invited to the correspondence resting with above noted subject and in such cases step-up cases are being sent to this Directorate such difference in pay is due to exercising of option on revision of pay scales.

On the basis of facts narrated above you are directed to settle the cases of revision of pay in HPCS(RP)Rules 2022 of all the Junior Assistant at your own level as and valid option exercised by the incumbent be kept pasted with service book to avoid any audit observation at later stages.

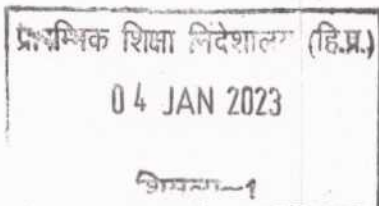
