ORDER

In the matter : CWP No. 8745/2022 titled as Yadvinder Thakur ,TGT(Med)VS State of H.P. & others.

The Petitioner,Sh.Yadvinder Singh,TGT (Med), filed CWP No. 8051/2022 titled as,Bhupinder Singh, versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Kutgarh Distt. Mandi ,(which fall under hard /Tribal area) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 20th Dec.2022 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order.

" In this view of the matter,we dispose of this petition with a direction to the respondents –State to consider the case of the petitioner and thereafter consequential order of transfer be passed ,positively within a period of three weeks from today. "

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 23rd October,2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner requested that he may be adjusted at GSSS Boys Mandi (due to retirement of present incumbent.) /GSSS Nagwain /GSSS Pandoh/GSSS Bajwara (KLU) against longer stay.

I have critically examined the case and observed that the petitioner has been serving as TGT(Med) in GSSS Kutgarh Distt. Mandi since 11th March,2019 and is entitled to be transferred as per transfer policy.Therefore,I find it appropriate to transfer the petitioner to GSSS (Boys) Mandi qua retirement of the present incumbent .The petition is accordingly disposed of.

ORDER

In the matter : **CWP No.7581/2022 titled as Parvesh Kumar,TGT(Med)VS State of H.P. & others.**

The Petitioner,Sh.Parvesh Kumar ,TGT (Med), filed CWP No. 7581/2022 titled as,Parvesh Kumar, versus State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Sholi Distt. Shimla to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 29th November.2022 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order.

"Accordingly ,without advertng to the merits of the case, we deem it appropriate to dispose of the writ petition of the writ petition by directing respondent No.2, Director of Elementary Education Himachal Pradesh, to consider and dispose of representation dated 12-06-2022. AnnexureP-6, moved by the petitioner expeditiously in accordance with law , preferably within four weeks from the date of receipt of the copy of this order."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 23rd October,2022. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner requested that he may be adjusted any of dthe following school:-

1. GMSSS Mandap Dsitt.Mandi
2. GBSSS Dehra Dsitt. Kangra.
3. GSSSBharari (HMR)
4. GSSS Lagbhaliyana (KGR)
5. GSSS Rampur Distt. Solan.

The petitioner has further stated that his wife Smt. Reenu,(Lecturer chemistry) is presently posted in GSSS Lagru Distt. Kangra and she lives alone with two kids there.

From the perusal of the record, it reveals that Sh.Parvesh Kumar,TGT(Med), has been working in GSSS Sholi Distt Shimla since 04th October,2017 and has completed his normal tenure at present place of posting. But,however keeping in view the fact that the post of TGT(Med),will fall vacant in the said school and the student will suffer in terms of their study as GSSS Sholi has a large catchment area of villages and adjoining panchayats and large number of student attend this school for elementary education, therefore, after critical examination ,and thoughtful application of mind,the representation of the petitioner is rejected and disposed of accordingly.

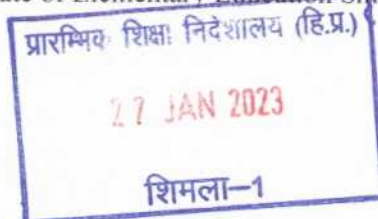
