**ORDER**

**In the matter :** CWP No. 9041/2022 titled as Suneel Kumar, /TGT(Med)VS State of H.P. & others.

The Petitioner, Sh. Suneel Kumar, TGT (Med), filed CWP No.9041/2022 titled as, Suneel Kumar, versus State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Rohal Distt. Shimla, (which fall under hard /Tribal area) to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 02<sup>nd</sup> January, 2023 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions / order.

*" Accordingly without adverting the merits of the case, we dispose of the writ petition with a direction that in case the petitioner moves a fresh representation before respondent No.2, at the Director of Elementary, Himachal Pradesh, in terms of the Transfer Policy dated 10-07-2013, within one week from today, the same shall be disposed of by respondent No.2, in accordance with law, within two weeks thereafter from the date of receipt of the representation moved by the petitioner, along with copy of this order."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 30<sup>th</sup> January, 2023. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner requested that he may be adjusted any of the following school:-

1. GHS Swana Swarghat Distt. Bilaspur.
2. GSSS Badagaon (BLP).
3. GSSS Samoh (BLP)
4. GSSS Jhandutta (BLP)
5. GSSS Nakrana (BLP)
6. GSSS Rail Jajri, Distt. Hamirpur

From the perusal of the record, it reveals that Sh. Suneel Kumar, TGT(Med), has been working in GSSS Rohal Distt. Shimla (which fall under sub cadre area) since 25-08-2018 and has completed his normal tenure at present place of posting, is ~~entitled~~ entitled to be transferred as per transfer policy. I find it appropriate to transfer the petitioner to GSSS Nakrana Distt. Bilaspur against vacancy. The petition is accordingly disposed of.
