ORDER

In the matter of: CWP No. 8717/2022 titled as Geeta Sharma Vs. State of H.P. & Others.

Whereas, Smt. Geeta Sharma, TGT (NM) preferred CWP No. 8717/2022 titled as Geeta Sharma Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Lahra District Chamba to the station near to her native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19.12.2022 when the Hon'ble High Court has passed the following orders:-

"3. Accordingly, without advertng to the merits of the case, this petition is disposed of with a direction to respondent No. 2 to consider and decide the representation (Annexure P-2 and P-3) moved by the petitioner in accordance with law expeditiously, preferably within three weeks from the receipt of the copy of this order.

4. Pending miscellaneous application(s) if any, shall also stand disposed of. For compliance, list on 03.03.2023."

Whereas, petitioner has submitted his representation in this office on 21.12.2022 thereafter she was also called for personal hearing on 24.03.2023 and she attended the same. At the time of personal hearing she requested that she has completed more than four years stay at her present place of posting and her husband is also Government Servant and serving at GSSS Sihla District Kangra as Lecturer in Higher Education Department. She further requested that she may be transferred to the stations near to her native place i.e. GHS Tikka Nagrota u/c GSSS Bhadwar District Kangra (ii) GHS Rinna u/c GSSS Bhadwar District Kangra (iii) GSSS Shahpur District Kangra (iv) Any other nearby station in District Kangra nearer to home station of petitioner with longer stay or falling vacant on promotions of TGTs to the post of Headmaster Lectuere etc.

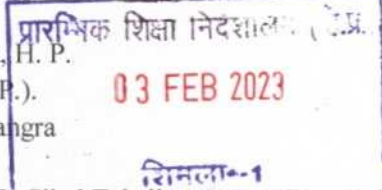
From perusal of record, it has been found that the petitioner has been working at GSSS Lahra District Kangra w.e.f. 1.09.2018 and has completed more than four years stay. One post of TGT(NM) is lying vacant in GHS Tikka Nagrota u/c GSSS Bhadwar District Kangra. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Lahra Distt. Chamba to GHS Tikka Nagrota u/c GSSS Bhadwar District Kangra against vacancy being a couple case, without TTA/JT. The representation of the petitioner is disposed of accordingly.
