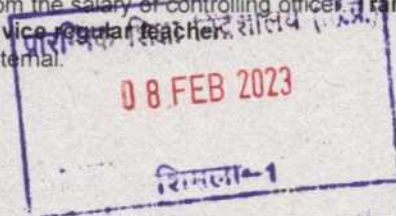
1. These orders may be implemented in relaxation of ban on transfers.

5. It must be ensured that the candidate is not specially abled.
