**ORDER**

In the matter of: CWP No. 7980/2022 titled as Sanjeev Kumar Vs. State of H.P. & Others.

Whereas, Sh. Sanjeev Kumar, TGT (NM) preferred CWP No. 7980/2022 titled as Sanjeev Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Deol District Chamba to the station nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 17.11.2022 when the Hon'ble High Court has passed the following orders:-

" 4. Accordingly, without adverting to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to the respondents, in terms of the transfer policy, dated 10<sup>th</sup> July, 2013, within a week from today, then the respondents shall dispose of the same, in accordance with law, within two weeks from the date of receipt of the representation.

6. Pending miscellaneous application(s), if any, also stand disposed of.  
To come up for compliance on 22.02.2023."

Whereas, the petitioner was called for personal hearing on 27.01.2023 and he attended the same. At the time of personal hearing he has requested that he has completed normal tenure of three years at his present place of posting i.e. GHS Deol District Chamba which is a hard/tribal area. He has further stated that he may please be adjusted in the stations given in the representation submitted by him at the time of personal hearing.

From perusal of record, it has been found that the petitioner has been working at GHS Deol District Chamba(hard/tribal area) w.e.f. 09.06.2015 on contract basis and his services were regularized on 13.11.2018. He has completed his required tenure of service in hard/tribal area but at present there is no vacant post in the stations/schools mentioned by the petitioner in his representation. However, one post of TGT(NM) is lying vacant in GHS Mungal District Kangra which falls in soft area. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is considered sympathetically and he is hereby transferred, without TTA/JT, from GHS Deol District Chamba to GHS Mungal District Kangra against vacancy, on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
