Whereas, Smt. Meena Arora, TGT (NM) preferred CWP No. 3971/2022 titled as Meena Arora Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Bard u/c GSSS Surhani District Bilaspur to GMS Bhadsin u/c GSSS Bharari District Bilaspur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22.06.2022 when the Hon'ble High Court has passed the following orders:-

Whereas, the petitioner was called for personal hearing on 17.10.2022 and 14.02.2023 and she did not attend the same. She has requested for her transfer from her present place of posting to GMS Bhadsin u/c GSSS Bharari District Bilaspur District Bilaspur, H.P.

From perusal of record, it has been found that the petitioner has been working at GMS Bard u/c GSSS Sunhani District Bilaspur w.e.f. 25.12.2019 and has completed three years stay. At present there is complete ban on transfers and the aforesaid school falls in soft area, therefore, petitioner is not entitled for transfer to the station of her choice. Moreover, TGT(NM) is State Cadre post and the incumbent is supposed to serve anywhere in the State as per requirement and administrative exigency. Thus, after thoughtful application of mind, the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
