ORDER

In the matter of: CWP No. 6315/2022 titled as Sarsawati Devi Vs. State of H.P. & Others.

Whereas, Smt. Sarsawati Devi, TGT (NM) preferred CWP No. 6315/2022 titled as Sarsawati Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Syar Dobha u/c GSSS Ranital District Bilaspur to GMS Tiun Khas u/c GSSS Kothi District Bilaspur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 12.09.2022 when the Hon'ble High Court has passed the following orders:-

" 3. In the circumstances, we dispose of this petition by permitting the petitioner to make a representation to respondent No. 2. If such representation is made within four week days from today, the same shall be decided expeditiously, and in any event, within three weeks from the date of receipt of the representation. Until the representation is decided, the petitioner would not be disturbed from her present place of posting, if not already relieved."

Whereas, the petitioner was called for personal hearing on 17.10.2022 and 14.02.2023 and she did not attend the same. She has requested in her representation that she may please be adjusted at GSSS Kandaur/GHS Badhyat u/c GGSSS Bilaspur District Bilaspur as she has a 17 years daughter with the 805 permanent disability totally bedridden to look after and her husband is also a Government Employee.

From perusal of record, it has been found that the petitioner has been working at GMS Syan Dobha u/c GSSS Ranital District Bilaspur w.e.f. June, 2021 on contract basis and has not completed three years stay. She has been transferred from her present place of posting to GMS Tiun Khas u/c GSSS Kothi District Bilaspur against vacancy in condonation of short stay & in relaxation of contractual policy vide this office letter of even number dated 5.09.2022. At present no post of TGT(NM) is lying vacant in GMS Tiun Khas u/c GSSS Kothi District Bilaspur as well as in the schools given by the petitioner for her adjustment in the aforesaid representation. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner in her representation is considered sympathetically and her transfer orders from GMS Syar Dobha u/c GSSS Ranital District Bilaspur to GMS Tiun Khas u/c GSSS Kothi District Bilaspur is hereby cancelled with immediate effect, on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
