**ORDER**

In the matter of: CWP No. 8380/2022 titled as Harvinder Singh Vs. State of H.P. & Others.

Whereas, Sh. Harvinder Singh, TGT (NM) preferred CWP No. 8380/2022 titled as Harvinder Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Gadgushaini District Mandi to the station of his choice. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 02.12.2022 when the Hon'ble High Court has passed the following orders:-

" 3. In the circumstances, we dispose of this petition by permitting the petitioner to make a representation to respondent No. 2. If such representation is made within one week from today, the same shall be decided not later than six weeks from the date of receipt of the representation.  
4. The writ petition to stand disposed of in the above terms, so also the pending miscellaneous application(s), if any."

Whereas, the petitioner was called for personal hearing on 22.02.2022 and he attended the same. He has requested for his transfer from his present place of posting to the stations of his choice in District Mandi against vacancy.

From perusal of record, it has been found that the petitioner has been working at GSSS Gadgushaini District Mandi w.e.f. 08.03.2019 and has completed three years stay. At present one post of TGT(NM) is lying vacant in GSSS Tandoo District Mandi. Therefore, after thoughtful application of mind, the request made by the petitioner is considered and he is hereby transferred from GSSS Gadagushaini District Mandi to GSSS Tandoo District Mandi against vacancy on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
