1. In case of Condonation of short stay willingness of the concern incumbent may be obtained first.

2. Willingness of the concerned teacher be obtained by the incharge/Head of the institution before relieving him/her, in case he/she is not willing for the transfer, then he/she may not be relieved and the case may be referred back alongwith his/her unwillingness in r/o mutual transfers.

3. If the incumbent has already served sub-cadre/hard/tribal/difficult area in that event he/she not relieved again to areas ibid.

4. It must be ensured that the candidate is not specially abled.

5. It must beensured that the candidate is not on the verge of retirement.

6. The transfer orders of TGT(s) issued from hard area to soft area may not be implemented without joining of substitute.

7. The incumbent(s) who has/have not completed three years tenure in his/her present place of posting transfer orders may not be implemented, if otherwise stay of the incumbent(s) not condoned.

8. Transfer orders issued in respect of TGT(s) working on contract basis may not be implemented, if contract policy not relaxed.

9. All provisions as contained in O/M No: PER (AP-3)E(3)17/2021 dated10.07.2013"Comprehensive guiding principles 2013 -----for regulating the transfer of State Govt. Employee at point no.5" consession to certain categories of employees and 5.5 of O/M dated 17.09.2015 must be adhered strictly.
