Whereas, Sh. Savroop Chand, TGT (NM) preferred CWP No. 8398/2022 titled as Savroop Chand Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Chhatrari District Chamba to the station nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 05.12.2022 when the Hon'ble High Court has passed the following orders:-

" Accordingly, without adverting to the merits of the case, we dispose of the writ petition with a direction that in case the petitioner moves a fresh representation before respondent No. 2, Director of Elementary Education, Himachal Pradesh, in terms of the Transfer Policy dated 10.07.2013, within one week from today, the same shall be disposed of by respondent No. 2, in accordance with law, within two weeks thereafter from the date of receipt of the representation moved by the petitioner, alongwith copy of this order."

5. Pending miscellaneous application(s), if any, shall also stand disposed of. To come up for compliance, on 10.03.2023."

Whereas, the petitioner was submitted his representations dated 6.12.2022. The petitioner was called for personal hearing on 27.01.2023 and he attended the same. At the time of personal hearing he has requested that he has completed normal tenure of three years at his present place of posting i.e. GSSS Chhatrari District Chamba which is a hard/sub-cadre area. He has further stated that he may please be adjusted at GMS Bhariyan / GSSS Sach / GSSS Mangla/GGSSS Chamba/GSSS Kariyan District Chamba against vacancy/longer stay.

From perusal of record, it has been found that the petitioner has been working at GSSS Chhatrari District Chamba w.e.f. 01.06.2006 on PTA basis. Thereafter his services were taken on Contract basis on 5.01.2015 and further regularized on 29.08.2020 and has completed more than 16 years stay. At present one post of TGT(NM) is lying vacant in GMS Bhariyan, U/C GSSS Mangla, Distt. Chamba . Therefore, after thoughtful application of mind, the request made by the petitioner is considered and he is hereby transferred from GSSS Chhatrari, Edu. Block Mehla, Distt. Chamba to GMS Bhariyan, U/C GSSS Mangla, Distt. Chamba, against vacancy, on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

Whereas, Sh. Rakesh Kumar, TGT (NM) preferred CWP No. 8296/2022 titled as Rakesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Sartoyla u/c GSSS Mahunag District Mandi to the station nearby his native place. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 01.12.2022 when the Hon'ble High Court has passed the following orders:-
