

ORDER

In the matter of: CWP No: 714/2023-Gopal Singh Vs. State of Himachal Pradesh.

Sh. Gopal Singh, TGT (Arts) has filed CWP No. 714/2023- before the Hon'ble High Court of H.P. regarding transfer from GSSS Kanti Mashwaa (Sirmour) to GSSS Tundi (Chamba) against vacancy. The case was listed on 20.02.2023, when the same has been disposed of with the following order :-

" The petitioner is permitted to make a representation to respondent No. 2/ Director Elementary Education to the Government of Himachal Pradesh, Shimla, within a period of three days from today and on receipt of such representation, respondent No. 2, is directed to decide the same within one week thereafter strictly in terms of Clause 16.1 of the "Comprehensive Guiding Principles-2013" for regulating the transfer of State Government employees.

In order to maintain equities, it is ordered that the petitioner shall not be forced to join at the station to which, he has been transferred till the decision of his representation.

The petition is accordingly disposed of, so also the pending application (s) if any.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Gopal Singh, TGT (Arts) has submitted representation vide which he has requested for adjustment at GSSS Tatiyana/ GSSS Dhang Ruhana GMS Lani u/c GSSS Tatiyana (Sirmour)/ GSSS Oachghat /GSSS Kotho (Solani.)


From perusal of the record it is revealed that Sh. Gopal Singh, TGT (Arts) was transferred from GSSS Kanti Mashwa (Sirmour) to GSSS Tundi (Chamba) against vacancy, with TTA/JT after completion of his normal tenure, with the prior approval of the competent authority. At present post of TGT(Arts) is lying vacant at GSSS Tatiyana, District Sirmour. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner in his representation is considered sympathetically and he is hereby adjusted at GSSS Tatiyana, District Sirmour, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
